



Dear Wyoming Parents and Youth,

Wyoming Students Against Destructive Decisions (SADD) and the Wyoming Association of Sheriffs and Chiefs of Police (WASCOP) are excited to be partnering together for the First Annual Wyoming Youth Summit.

We are so glad you are registering for the Wyoming Youth Summit. Mallo Camp is an outdoor, rustic camp located near Newcastle, Wyoming in Weston County. We are so excited to spend this time with you! The enclosed forms are required for your attendance. Please take the time to read the forms thoroughly, fill them out and bring with you to camp on July 30th. These documents contain important information that will help you plan, pack and prepare for this summit, as well as will be needed for you to check-in.

Check-In and Check-Out --

Participants will be able to check in on Monday, July 30th from 2 pm to 4 pm. Please, no early birds. Follow the signs to the check-in area. Opening ceremonies will be at 4:30 pm with dinner to follow. The conference ends on Thursday, August 2nd at noon. Please plan for an on-time arrival to pick your child up.

Transportation –

Parents are responsible for transportation to and from the event. Participants will only be allowed to leave with a family member or designated adult as indicated on the release form. Participants may arrive in their own vehicles but are not allowed to leave the camp facility at any time and will be required to check their keys into the camp director during check-in. Participants agree to remain on the camp grounds and follow the conference rules. If you are a parent and would like to attend closing ceremonies, you may join us at 9 am on Thursday, August 2nd.

Directions to Mallo Camp –

Mallo Camp and Motel is located 17 miles north of Newcastle WY. From FourCorners off US-85, travel 4.5 miles down Mallo Rd to reach Mallo Camp.

Medical –

The Medical Information Form will be kept confidential and used only in case of emergency. During the conference, volunteers/staff trained in first aid will be available for routine minor first aid. In the unlikely event of a medical emergency, emergency personnel will be called to the camp and the medical treatment form signed by a parent or guardian will be utilized. Participants requiring a doctor's treatment will be transported to the nearest medical facility. Parents or guardians will be contacted as soon as possible, using the information provided on the participant's medical information form. Please make sure this information is current, legible, and correct.

All prescription or over-the-counter medications used by participants should be listed on the Medical Information Form and clearly labeled in original containers. We ask that participants who bring prescription medications report to the Camp Nurse during check-in.

Lodging and Facilities –

Mallo Camp cabins are comfortable but are not air conditioned or heated. The main cabin where the conference will take place sits in the middle of camp with "boys" cabins on one side and "girls" cabins on the other side. There will be at least two male adult chaperones in each boys cabin and at least two female adult chaperones in each girls cabin.

The cabins are not secured for valuables. Please do not bring large amounts of cash, valuable jewelry, expensive cameras, or other irreplaceable items to the conference. Neither the camp, nor the conference sponsors will be responsible for lost, or stolen items. Cell phones and other electronic devices are restricted to free time.

Supplies for Camp

Optional items are welcome and can be taken by your child, such as camera, watch, compass, magnifying glass, flashlight, binoculars, etc.; however, youth will be responsible for these items.

1. Due to Wyoming's unpredictable weather, please be sure your child takes adequate warm clothing. It is better to be overdressed than to be cold and miserable.
2. Please label EVERYTHING with a permanent marking pen.
3. Each student's baggage should consist of not more than one suitcase or duffel bag.

Suggested supplies:

- Warm Sleeping Bag
- Warm Blankets
- Pillow
- Towel
- Wash Cloth
- Soap
- Comb and Brush
- Toothbrush and Toothpaste
- Kleenex
- Chap Stick
- Jacket/Coat
- Rain Gear (or heavy-duty garbage sack)
- Gloves/Mittens and Hat
- Sweatshirt or sweater
- Tennis Shoes
- Boots or Extra pair of Shoes
- Socks (2 pairs)
- Pajamas (warm)
- Long Underwear
- Blouses or Shirts
- Jeans or Slacks
- Insect repellent
- Sunscreen
- Shorts

Your child's clothes need not look "attractive." They do need to be able to be cool or warm. The "layer" approach is best – then a student can either add or subtract clothes as the weather indicates. Any additional camping clothes that you feel necessary may be added. There is always the possibility of clothes getting wet if it rains. The cabins at Mallo Camp are rustic but do have bunks with mattresses to sleep on. You may wish to send a mattress cover with your child as there are not sheets on the beds.

Wyoming Youth Summit 2018 PARTICIPANT CONFERENCE RULES AND REGULATIONS CONTRACT

The Wyoming Youth Summit is committed to providing a safe environment where the safety, health, and the wellbeing of conference attendees are preserved. Conference Rules and Regulations have been established to uphold the overall mission of the Wyoming Youth Summit and Wyoming Youth Coalitions, which is to empower youth in making healthy decisions and creating a healthy environment for themselves and those around them. All those who attend the Wyoming Youth Summit are expected to model, support, and follow Conference Rules and Regulations at all times. The Wyoming Youth Summit abides by and enforces a NO-TOLERANCE POLICY. All bags are subject to search. Please read the Rules and Regulations form thoroughly. All persons attending the 2018 Wyoming Youth Summit must sign and bring to conference as part of the check-in process.

Attendance: Participation and attendance at all meals and activities is required of all participants.

Remain on Grounds: All participants must remain on Mallo Camp property within the boundaries at all times.

Tobacco/Vaping/Alcohol/Drugs: Tobacco and Vaping products, alcohol, and drugs are not permitted. For the health and safety and the consideration of everyone attending, smoking and/or the use of any of these products is not permitted.

- At no time shall a person use or be under the influence of an illegal drug or harmful substance.
- At no time shall a person be under the influence of or consume alcohol of any kind.
- If any participant chooses to engage in this behavior, parents will be called to pick up their child.

Prescription Medication: Prescription medication must be documented on the medical form and turned in at the time of check in. Prescription medications will be monitored and dispensed by the camp nurse.

Social Responsibility: All participants are expected to conduct themselves in a mature and responsible manner. Good citizenship, self-control and appropriate behavior is required at all times. All participants are expected to respect one another and personal property. All are expected to work together as a team to ensure a positive camp experience for all. Any behavior which is harmful, demeaning or offensive to others, is not permitted. All attending will be required to respect and assist in maintaining a clean/safe camp environment, including; grounds, cabins, buildings, and any other property.

Weapons: Firearms/ammunition, explosives, knives or any other type of item that is considered to be dangerous is not permitted on camp grounds. These items will be confiscated.

Personal Items: The Wyoming Youth Summit (SADD, WASCOP, Mallo Camp and all sponsoring entities) are not responsible for lost, missing, stolen or broken personal items. Personal items should be clearly labeled. Expensive electronics are not advised; bring these types of items at your own discretion.

Parental Consent for Minor’s Participation
Release and Waiver of Liability
And Assumption of Risk Agreement

FOR GOOD AND VALUABLE CONSIDERATION, including participation in the Wyoming Youth Summit and related activities, I, the parent/guardian of the minor child for myself and on behalf of the minor:

1. Consent to the minor’s participating in the event and activity. The level of participation in the Wyoming Youth Summit is at all times completely up to the individual.
2. Acknowledge that each participant must assume the risk that he or she may suffer an emotional or physical injury or disability while involve in any outdoor physical activity. I understand that certain activities at the Wyoming Youth Summit may be physically or emotionally demanding. I affirm that my child/ward’s health is good, and that I am not or my child/ward is not under a physician’s care for any undisclosed condition that may affect my or my child/ward’s fitness or ability to participate in physical activities.
3. Recognize the inherent risk of injury, disability or death in physical activities, and I assume the risk of participating in these activities on behalf of myself or my child/ward.
4. Understand that such risks may include falling from heights, drowning, or being hit by an object, among other risks, including unknown risks.
5. Assume any and all risks of personal injuries to the minor, including medical or hospital bills, permanent or partial disability, death, and damage to my property, caused by or arising from my child/ward’s participation in this event or activity.
6. Agree that photographs, pictures, slides, movies, or videos of the minor may be taken in connection with the minor child/ward’s participation in the event or activity without compensation and consent to the use of photographs, pictures, slides, movies, or videos for any legal purpose.

This document relieves the Wyoming Youth Summit, Wyoming Association of Sheriffs and Chiefs of Police (WASCOP), Students Against Destructive Decisions (SADD), Mallo Camp, and sponsoring entities from liability from any and all claims made on behalf of myself or my child/ward for bodily injury, including death, resulting from participation in the Wyoming Youth Summit’s programs and activities, whether such claims arise from negligence or otherwise.
